## **Fees and Levies 2024**

Please find the tuition fees and levies for the 2024 academic year. The levies are inclusive of curriculum, excursion, swimming, and camp levy.

The fees and levies for 2024 reflect rising educational costs as well as operating costs not covered by government funding to Catholic schools.
